# **DUI Enforcement Beyond Alcohol: The Tennessee Experience**

A police officer has probable cause to stop someone for a possible DUI, only to have the BAC come back negative or not consistent with the actions of the driver. What can the officer do? Many allow the individual to drive away. In 2008 approximately 9,500 evaluations and subsequent arrests were conducted nationwide on individuals who had no or low BAC. Under normal circumstances the majority of those 9,500 drivers would have been allowed to drive away from the scene of the stop, creating the ongoing potential to be a crash waiting to happen. Enter the Advanced Roadside Impaired Driving Enforcement (ARIDE) and the Drug Evaluation & Classification Program, more commonly referred to as the Drug Recognition Expert (DRE) Program. These two police training programs, in conjunction with the Standardized Field Sobriety Testing (SFST), will provide state and local agencies with the tools to identify and evaluate both alcohol and drug-impaired drivers. A bonus to the DRE training is that approximately 1.60% of the total evaluations identified 200 individuals with medical conditions, which were subsequently handled. Learn how to replicate these programs in your community to ensure that DUI enforcement is not just a one-track approach. Also, find out how these programs can be used as bridges to the Drug Impairment Training for Education Professionals (DITEP) and other community needs in drug education.

# Poster I Judicial Concerns in Dealing with DWI Defendants

This poster session presents results of a survey that asked Texas District and County Court at Law Judges to report and rank their three most troublesome or frustrating problems when dealing with DWI defendants. Since resources for courts are always scarce, states can replicate this survey and/or use these results to focus legislative priorities, design judicial education programs, and provide services that address pressing problems identified by judges who hear impaired driving cases.

# Poster 2 We Did It Safely and Efficiently – Moving a Pediatric Rehabilitation Facility

**Authors:** Patricia D. Foley; Kevin W. Sullivan — Children's Specialized Hospital

Children's Specialized Hospital is the largest pediatric rehabilitation system in the United States. In December 2007, our child passenger safety team participated in the coordination of the transport of our inpatient rehabilitation patients to a new state-of-the-art facility in a safe and efficient manner. Our challenge was to assure the safe transport of forty-four special needs children with a range of medical conditions. The children needed to be transported 45 minutes on New Jersey highways to our new location in the City of New Brunswick. The ages of the children ranged from infants to adolescents. Their level of independence varied greatly. Some of the children were able to ambulate and sit independently and others were fully dependent. Our population of children includes but is not limited to the following; ventilator dependent patients, patients with obesity, head and spinal cord injury, premature infants as well as a variety of medical and orthopedic conditions.

# Poster 3 Sustaining Coalitions: The NWA Safe Communities Experience

Author: Ches Jones – University of Arkansas

The Northwest Arkansas Safe Communities Coalition began in March 1997. Over the past 11 years the coalition has remained a strong coalition within the region that provides services related to child safety seat checkups and underage drinking prevention initiatives. The success of the coalition to remain in place for over 10 years relied on several factors. The factors include 1) remaining focused on one or two highway safety issues, 2) growing the coalition moderately within the city and region, 3) constant leadership, and 4) involving community and enforcement agencies within the coalition struc-

ture. This poster will provide more details on how each of the above factors contributed to the growth and longevity of the coalition.

# Poster 5 Self-Reported Alcohol-impaired Driving Among Adults in the United States, 2006

Authors: Ruth A. Shults; Laurie Shults – Center for Disease Control

Alcohol-impaired motor vehicle crashes claim about 13,000 lives each year in the United States. In this study, we estimated the prevalence of alcohol-impaired driving (AID) among adults using 2006 data from the Behavioral Risk Factor Surveillance System (BRFSS). Information is obtained through telephone surveys of randomly selected, non-institutionalized adults aged > 18 years. AID was assessed by asking, "During the past 30 days, that is since \_\_\_\_\_, how many times have you driven when you perhaps had too much to drink. Of the 347,790 BRFSS respondents, 1.3% of women and 3.9% of men reported at least one AID episode in the past 30 days, totaling 161 million annual AID episodes. The national rate of AID episodes was 719 per 1000 population. AID was more frequent among men that women (1211 vs. 255 episodes per 1000 population). AID rates varied 15-fold across states, from 121 per 1000 population in Utah to 1819 per 1000 population in Iowa. States in midsection generally had higher AID rates than those in the south and northeast.

# Poster 6 Restraint Use Proves Effective in Preventing Injuries

**Authors:** Pam Holt, RN, BSN; Sue Mutto, RN, MA; Janice Kelley, RHIA, CSTR — St. John's Trauma Center

A 2006 law strengthening Missouri's child passenger safety law is paying off according to St. John's Trauma Center in Springfield, MO. A four year study of pediatric trauma patients admitted due to motor vehicle crashes looked at restraint use in comparison to injury rates, injury patterns, injury types and severity of injuries. The study shows a 23% decrease in the number of pediatric

patients admitted due to motor vehicle crashes in the two year period immediately following the law taking effect as compared to the two year period immediately prior to the law. The greatest decrease, 29%, was in the 4-7 year old range.

# **Poster 7**Homeless Children's Initiative

Providing safe and appropriate transportation for homeless children to receive medical services in a city-wide homeless initiative in Fort Worth, Texas involved a vast array of people and collaboration. The use of Child Passenger Safety best practice standards has proven to be both challenging to implement and fruitful in the education passed on to all involved.

# Poster 8 Multi-Agency Collaboration for Underage Drinking Prevention in West Virginia

# Poster 10 Should Libraries Check Out of Driver Education?

# Poster II Institutionalization of Evaluation in Georgia Traffic Safety Programs

Beginning in FY2004, the Georgia Governor's Office of Highway Safety (GOHS) utilized the Traffic Safety Research and Evaluation Group (TSREG) at the University of Georgia to evaluate grantees and GOHS as a whole. TSREG utilizes a systematic process to monitor program operations, give feedback to grantees, and gauge effectiveness. Over the past five years, GOHS grantee milestone and objective achievement rates increased 38% and 19% respectively.

# Solicitors and Law Enforcement: A Partnership for Successful ALS Outcomes

A preliminary study of Administrative License Suspension (ALS) hearing outcomes in Georgia reveals license suspensions are lifted most often due to the officer failing to appear (FTA) at the hearing. In response to this finding, a solicitor was provided to train officers before hearings, to accompany officers to hearings, and to provide technical assistance about hearings upon request. Our project examines the impact of this partnership on ALS hearing outcomes. Does this dynamic duo hold the key to keeping intoxicated drivers off Georgia roads?

# Poster 13 Do Grant Programs Impact the Safety of Georgia Roads?

Authors: James Barlament; Carol Cotton; Maggie Benson; Stuart Fors – Traffic Safety Research and Evaluation Group

Since FY2004, the Traffic Safety Research and Evaluation Group (TSREG) evaluated grants for the Georgia Governor's Office of Highway Safety (GOHS). Over this period, TSREG reported improvement by GOHS grantees in achievement; however, a consistent reduction of crashes, injuries and fatalities on Georgia roadways has

not followed the success of grantee programs. This raises the fundamental question: What impact does the money GOHS spends on its grant programs have on the safety of Georgia roads?

# Poster 14 Rural Road Safety in Georgia: Making a Difference One Person at a Time

The Regional Community Liaison (RCL) Project is a 4-year pilot project intended to address the issue of traffic safety data collection, maintenance, and analysis at the local level in Georgia. The goal of this project is to test the impact of strategically positioning RCL representatives throughout the state to: (1) act as a resource for local traffic safety professionals; (2) assist in data collection and research; and (3) support funded traffic safety projects in the community.

# Child Passenger Safety Focus Groups – How Well are Our Educational Materials Working?

Safe Kids Connecticut and Safe Kids Greater Naugatuck Valley ran two focus group sessions of parents and caregivers that looked at how they responded to different child passenger safety educational materials. Results included that male and female participants preferred their information in different formats, that participants preferred a positive approach rather than a fear approach, and that many participants turned to the internet for advice, but did not always trust it.

# Safe Communities Coalitions of Minnesota

Approximately 500 lives are lost on our roadways each year in Minnesota. Vehicle crashes also account for around 35,000 injuries every year. The twenty three Safe Communities Coalitions across the state operate at a community level and primarily focus around disseminating key traffic safety issues out to the general public through a variety of creative activities. The efforts of the Coalitions have been instrumental in lowering vehicle fatalities.

# **Poster 17**Injury Prevention in a Rural Navajo Community

**Author:** Mary Robertson — Begay-Hardrock Council on Substance Abuse, Inc.

Disabling injuries and injury-related fatalities are among the leading public health issues faced by American Indian/Alaska Natives communities. They are especially tragic in isolated rural communities, where a lack of medical and rehabilitation resources magnifies the impact of injuries, and close networks of families and neighbors share the suffering individuals. The Hardrock Chapter is one such rural community. The community of Hardrock is a story of how a tribal community became empowered to make changes despite the overwhelming challenges of historical trauma, political land disputes and lack of resources. Hardrock successfully secured funding that led to the development of an injury prevention program with an emphasis on motor vehicle safety.

# Characterization of Motor Vehicle Crashes Involving Cell Phone Use in New York

**Authors:** Tiffani Ann Fordyce, MPH; Michael Kelsh, MPH, PhD; Edmund Lau MS - Exponent

The state of New York passed pioneering legislation to ban the use of hand-held cellular phones while driving in 2001. Shortly thereafter, codes for cellular phone usage (both hand-held and hand-free) were added to Police Crash Reports (PCRs). We examined 4 years of crash data (2002-2005) for New York to identify crashes where cell phone use was coded as a contributing cause. There were, on average, around 250 of these crashes per year. These crashes were analyzed to determine vehicle, demographic, and environmental characteristics commonly involved in crashes where cellular phone use was a factor.

# Poster 19 Using State Crash Data to Assess the Risk of Cell Phone Use While Driving

**Authors:** Tiffani Ann Fordyce, MPH; Michael Kelsh, MPH, PhD; Edmund Lau MS – Exponent

In 2001, the state of New York enacted the first ban on hand-held cellular phone use while driving. Other states have since passed similar legislation: New Jersey and the District of Columbia in 2004; Connecticut in 2005; and California in 2008. However, assessing the actual crash risk associated with cellular phone use while driving is proving to be difficult. The majority of states do not collect information regarding the role of cellular phone involvement in crashes on Police Crash Reports (PCRs). In the 23 states that do code this information, the data collection just began in recent years. It is also necessary to consider the quality of the available information as cellular phone use is likely underreported in crash databases for a variety of reasons. Cell phone use may not be coded consistently by police officers or may be unreliable as investigators must rely on witnesses or self-reporting to determine whether a phone was in use at the time of the crash. Based on existing data from state crash databases, it would appear that cellular phone use is a factor in less than 1 percent of motor vehicle crashes. Given the small number of crashes where cell phone use is coded as a contributing cause, it is likely that statistically significant conclusions regarding both the crash risk associated with cellular phone usage, and the effectives of legislation prohibiting cell phone use while driving are not possible

# Poster 20 Safe Ride Programs – How to Increase Riders

The Kansas Traffic Safety Resource Office partnered with Kansas Universities to promote the universities SafeRide programs. With implementation of media, promotional materials, local community awareness partnered universities have increased ridership on their SafeRide programs thus decreasing the number of students driving under the influence. The University of Kansas increased ridership 119% from FY08 to FY09 along with an increase of 14% at Wichita State University are two successes of the eight partnered programs.

# Poster 2 I Child Passenger & Occupant Protection Education: Getting Healthcare Providers Involved

Authors: Pamela Homiak, RN BSN MPH CPST; Cyndy Wright-Johnson, RN MSN; MIEMSS — Maryland Institute for Emergency Medical Services System (MIEMSS)

This unique project, in its eighth year of implementation in the state of Maryland, focuses on healthcare providers across the continuum of care (from EMS personnel to physicians) as important partners in efforts to educate parents/guardians on passenger safety topics. Project staff provide technical support to healthcare providers through a carefully constructed network of hospital staff and community liaisons. The project has also created and distributed creative, targeted resources to providers through a variety of channels. This poster offers a how-to guide for expanding child passenger safety (CPS) and occupant protection (OP) education efforts to reach those healthcare workers who are routinely called on to provide CPS and OP education to parents.

# Poster 22 Teen Motorcycle-Related Hospitalizations and Traumatic Brain Injuries in the United States, 2006

Authors: Harold Weiss, Ph.D; Yll Hyseni, MPH; Claudia Steiner, M.D. – Center for Injury Research and Control, University of Pittsburgh

This study describes the characteristics of hospitalized teen motorcycle injuries and quantifies the national burden of motorcycle related traumatic brain injury (TBI) for youth age 12-20. This cross-sectional analysis of the 2006 KIDS' Inpatient Database (KID) of the Healthcare Cost and Utilization Project (HCUP) was conducted in 2008. It includes comparisons of the number and proportions of the TBI to non-TBI cases and comparisons of traffic and non-traffic motorcycle related crashes. The poster will describe differences in hospitalization characteristics between these groups with regard to length of stay, hospital type, hospital size and charges. Injury severity variables were added to each case. The Healthcare Cost and Utilization Project KID Database (KID-HCUP) was used to estimate the national burden of youth

motorcycle related hospitalized head injuries. KID contains acute care hospitalization data for U.S. children and adolescents residing in 38 states.

# Poster 23 Brains At Risk: A Prevention and Awareness Program of the Brain Injury Association of Massachusetts

Authors: Brain Injury Association of Massachusetts & Emily S. Ring, CBIS & Manager of Court-related Programs — Brain Injury Association of Massachusetts (BIA-MA)

Brains At Risk is a court-referral prevention and awareness program of the Brain Injury Association of Massachusetts for individuals, ages 17 and older, which links the choices made behind the wheel to the devastating effects of traumatic brain injury. The mission of Brains At Risk is to promote responsible driving and raise awareness of traumatic brain injury in order to prevent fatalities and serious injury on Massachusetts roads.

# Poster 24

# "Giving Back the Road to Sober Drivers:" Preventing Motor Vehicle Crashes on San Carlos Apache Reservation

Authors: Christine Reede; Alejandro Benally; Stephen Piontkowski, Gordon Tsatoke, Jr. and Robert Letourneau – San Carlos Police Department

The San Carlos Apache Motor Vehicle Injury Prevention Program, operated by the tribal police department and funded by CDC, set out in 2004 to reduce alcohol impaired driving and reduce motor vehicle crashes (MVC) and injuries through the implementation of effectives strategies. Sobriety checkpoints, saturation patrols, work towards stringent laws (0.08 BAC and primary occupant restraint), and program marketing were some of those strategies. Between 2004 and 2008, DUI arrests increased 52% and overall motor vehicle crashes decreased 61%. We demonstrated successful completion of effective strategies to reduce the impact of MVC in a Native American population and recommend a similar approach by other tribal entities.

# **Poster 25**Injury Prevention in Indian Country

Authors: Barbara Hart; Karen Santana; Jackie McCormick — California Rural Indian Health Board, Inc.

Injury Prevention Trends in Rural Tribal Communities and the Development of Injury Prevention Toolkit - This poster will share a valuable resource for tribal communities who have limited resources in the area of injury prevention and for non-tribal groups to use as a guide for developing their own injury prevention tools specific to their communities served. This toolkit has been developed specifically for use in tribal communities as a resource to be used when thinking about injurypPrevention. The toolkit focuses on five major injury prevention topics: Seat Belt Safety, Child Car Seat Safety, Helmet Safety, Fire Safety, and Elder Safe.

# **Poster 26**Avoiding Labels in Indian Country

**Author:** Luis Salas — Northern Native American Health Alliance

With this presentation about Avoiding Labels in Indian Country, I will describe the process used to implement the anti-bullying program Creating Caring Communities throughout the Ashland Public High School system in Northern Wisconsin, including the three nearby communities of the school system and with the support of elected representatives from those communities. The original plan for the project was to conduct an anti-bullying project in the Bad River Tribal community alone, however, project collaborators concluded that 'we cannot win unless we all win' and decided that to approach the problem of bullying in only one community is to "label" that community as having a problem. Public health and traffic safety professionals working in Native American Communities have long understood that labels are "yokes" and barriers that have alienated Tribal Communities from their non-tribal neighboring communities. With the success of our project, we have succeeded in developing the skills of a cadre of anti-building advocates in each of the communities surrounding Ashland, WI.

# Poster 28 Enhancing Child Passenger Safety in Tennessee

Authors: A. Dexter Samuels, Ph.D.; Dr. Terri Foxx; Dr. Owen Johnson; Mr. Tedric Robinson — Children Are Restrained for Enhanced Safety (CARES)

It has been found that income level and race are determining factors in the utilization of vehicle restraints. Studies have shown that there are racial differences in the use of seat belts for children. Also it has been noted that a driver who is restrained is three times more likely to restrain a child than one who is not restrained. In an effort to reduce the disparity of injury for minority and low-income children the Children are Restrained for Enhanced Safety (CARES) project at Tennessee State University has been organized. This project sought to highlight the underutilization of child passenger safety restraints and effective community-based interventions to increase restraint usage.


