



## 2021 Lifesavers Virtual Conference Speaker/Moderator Release Form

### Liability/Webinar Recording Waiver

In consideration that the 2021 Lifesavers Conference will be held virtually, and based on the acceptance of your willful submission to present a virtual presentation, you agree to the following terms and conditions:

By agreeing to participate as a speaker/moderator for, you agree and acknowledge that you are participating in 2021 Lifesavers Conference events and activities of your own free and intentional will.

In the event that the Lifesavers Conference records your presentation as part of a Lifesavers Workshop; either before the live viewing of the virtual Workshop to be presented as a hybrid-recording/live question and answer (Q&A) or for post-virtual conference viewing, all 2021 Virtual Lifesavers Conference Workshops will be made available on the Lifesavers website and for distribution to Lifesavers Virtual Conference participants. In addition, the virtual Workshops may be live-streamed to several social media platforms. Links to each virtual Workshop may be shared by attendees and other on-demand viewers. In the event that Lifesavers does not record the Webinar or make it available to participants, it is understood that individual viewers of the virtual Workshops may be able to acquire presentation slides and the content provided during the virtual workshop through their own means, such as screenshots, personal recording software, etc.
